- The installation of Tempo Timesheets takes longer than usual because of data migration so you might want to upgrade outside of office hours.
- Data might be lost if you downgrade to an earlier version after you upgrade Tempo Timesheets from version 7.x.x to version 8.x.x or later.

About Add-on Subscriptions

While you can't install add-ons to a JIRA Cloud instance, you can extend JIRA by subscribing to add-ons. The Atlassian Marketplace makes a set of selected add-ons available to users in the cloud.

You can manage your add-on subscriptions from the add-on administration page in the instance.

The management tasks you can perform in the add-on administration page include:

- Find add-ons you can license in your add-on instance
- Start a trial and subscribe to an add-on
- · Deactivate an add-on

Viewing Available and Subscribed Add-ons


To see what add-ons are available for your JIRA Cloud instance, go to the Manage Add-ons page. Add-ons that are available for your instance appear in the Action Required list with a **Free Trial** button.

The Action Required filter also shows add-ons that have subscriptions due to expire within 30 days or that have recently expired. Otherwise, you can find a subscribed add-on by selecting the user-installed filter option.

Trying and Subscribing to an Add-on

In Atlassian Cloud terms, you buy an add-on by subscribing to it. An active add-on subscription activates the features of the add-on in your JIRA Cloud instance.

To try or subscribe to an add-on, click the Free Trial button next to the add-on in the Manage Add-ons page.



You click this button whether you're ready to subscribe or just want to try the add-on for now. If you do not terminate the trial within the trial period, a subscription for the add-on kicks in. Trials last for a month from the start of your next billing date. After starting a trial, you can stop it from the add-on administration page.

Although you can re-enable the trial within the original trial period, you cannot try it again beyond the original trial period. At that point, you will only be able to subscribe to the add-on from the Manage Add-ons page.

Canceling an Add-on Subscription

You can terminate a subscription for an add-on by clicking the Unsubscribe button for the add-on in the Manage Add-ons page.

Canceling an add-on takes effect immediately and you will be not refunded.

Some add-ons may retain functionality even after the license period ends. If you'd like to completely stop an add-on from appearing in the interface, disable it as described in Disabling or Enabling a JIRA Add-on.



Procedure

1. From any timesheet, in the upper-right corner, click Log Work.



2. In the Log Work window, fill in the requested information.

User	In the User field, you can select a different user if the following conditions are true:
	 You have Approve Timesheet permis sion. The option 'User with Approve Timesheet Permission can log work for team members' is enabled in the Tempo global configuration.
Issue	In the left column, you can filter the issues that are available in the Issue field. You can select Internal, Assigned, Watched or Filter.
	The left column is <i>not</i> displayed if you clicked Log Work from the <i>issue</i> timeshee t because the issue is already selected.

Remaining estimate	The remaining estimate depends on the setting 'Remaining estimate is optional' in the Tempo global configuration: If that setting is selected, and the issue does not have an original estimate, the remaining estimate is not calculated. If that setting is selected, and the issue has an original estimate, the remaining estimate is reduced by the time that is logged until the remaining estimate is 0, in which case you can increase the remaining estimate. The remaining estimate cannot be a negative number.
Description	A description is optional if the Worklog description is optional checkbox is selected in the Tempo global configuration .
Extra fields	The window might contain extra fields if Te mpo worklog attributes are configured.

- 3. If you plan to log more work immediately after you log this work, at the bottom of the window, select **Log another**.
- 4. Click Log Work.

Issue Log Work dialog

The issue Log Work window is different from the Tempo Log Work window as the JIRA issue is pre-selected and the left sidebar is not displayed. This Log Work window is accessible from a timesheet cell and from the JIRA issue view.

Timesheet Cell

Time can be logged on issues from a timesheet cell, given the issue is displayed in the timesheet, either because time has been logged on it before or because of a selected filter.

This can be done in the User and Issue Timesheets. A Team Lead or a user with the Approve Timesheet permission can also log work directly on an issue in the Advanced Timesheet.


To log work from a timesheet cell, click on a day for the issue you want to log work on and a Log Work window with the issue pre-selected in the issue picker is opened.

In this version of the window you only have to fill out **Worked** hours, **Remaining estimate** if required and give a brief **Description**.

If remaning estimate is required, the value is displayed in pretty format.

Already logged work can be edited in-line in the timesheet. The timesheet in-line window looks as in the screenshot below, where you simply click on the items you want to edit, given the period is open. You can also click the Log Work button in the in-line window to add a new worklog.














In this chapter

The Plan Time window has an orange header to differentiate it from the Log Work window. The left sidebar has default the options *Issue* and activities *Project*, *Version* and *Component*. If an Internal Activity has been configured the *Internal* tab becomes available.

Plan on Issue

The first option for planning is Issue where you can plan time on a JIRA issue. The *User* field is a *User Picker* for users with Approve Timesheet permission using this plan time function.

The Plan Time window showing the Issue option in the side menu (click to enlarge)




To plan time on an issue, follow the steps below:

- 1. Once you have opened the window, select the **Issue** option on the left sidebar.
 - The last option that was used, is selected by default.
- 2. Choose an issue from the drop-down in the Issue field (you can also start writing).
- 3. If you tick the **Period** box, an **End date** field for the time period is displayed.
- Select a new Date (and End date) if you are planning on another date than the current one.
 - Availability (Working days) is displayed below the date in the window. These numbers reflect the users workload schemes and holiday schemes, and if some plans have been done previously on her/him for the date.
- 5. Fill a number into the field **Planned** for the hours to be planned on the issue (if period is chosen, the field is called **Plan per day**).
 - Remaining estimate and Original estimate are displayed above for information purposes only, e.g. it doesn't make sense to plan more than the original estimate indicates.
- 6. Write a brief description in the **Description** field.
 - The description is optional and can therefore be omitted.
- 7. Click the **Plan Time** button if you are done planning or **Cancel** to close without saving. You can also continue to plan, by ticking the **Plan another** box before your click the **Plan Time** button, but this means that the window stays open to do a new plan time entry.

Issue Planning from Action list

The plan time window can be opened from the User timesheet, by selecting the **Plan Time** option in the **Actions** list for an issue in the timesheet.


The Plan Time options in the Actions menu for the AKA-20 issue in the user timesheet




Other Options

As mentioned above it is also possible to plan on activities or *Project, Version* and *Component*, and if an Internal Activity has been configured the *Internal* tab becomes available. The plan time window for these other options, does not display *Remaining estimate* and *Original estimate*, since they are associated with issues. The screenshots below show the difference for each option.


Planning time on Project (choose a project from the drop-down; click to enlarge)




Planning time on Version (choose a project and a version of it from the drop-downs)





Displaying information for one bar

In the team utilization table, you can display information for a single bar of the chart by clicking the bar. You can reset the table to show all data from the chart by clicking the bar again.

If the account, account category, customer, or account category type is not defined for issues, logged time is displayed in gray in the chart and table. You can add the missing information by resolving unaccounted hours.

All account attributes can be updated, except the account Key. If the project link in an import file is **not** found on your JIRA instance, the account is not imported. This is reported in the message given at the final step of the import.

1 This entry in an import file can be corrected if appropriate and then imported again.

The possible account statuses are: **Open**, **Closed** or **Archived**. The table below describes how these statues are acquired and when the status is not affected by import.

Table: Explaining account statues and when it is not affected by import

Status	Description
OPEN	This is the default status for newly created or i mported accounts. The status can also be set by manual configuration, given the account has previously had another status.
CLOSED	Accounts can only get this status by manual configuration.
ARCHIVED	This status is used for the following import cases: • An existing account (created manually or by import) is not in an import file and has no project link (and is not global). • Existing imported accounts, that are not in the next version of the import file. Accounts can also be <i>Archived</i> manually.

In this chapter

Unaffected

For existing accounts, the status is unaffected in the following import cases:

- An existing account (created manually or by import) that is in an import file, but has no project link (and is not global).
- For the case of imported and then manually edited accounts, where linked projects are affected, the status stays the same as before. If the first import has project links A and B, then project link C is added manually and in a new import the only project links are D and E. This means that after the import, the project links are going to be C, D and E, or only the imported links are updated, not the manually added ones.

A few notes:

- Only Open accounts will show up in JIRA issues and/or the Log Work dialog, depending on configuration.
- Tempo Timesheets reports can be created including Closed accounts, but not Archived a ccounts.
- The only way to look up Archived accounts, is by searching for them in the Accounts Navigator or select the Archived option in it's sidebar.



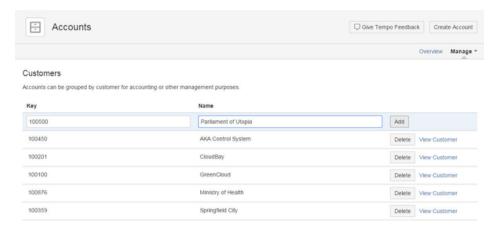







The rates defined in price tables are used to calculate revenue in the account revenue report and the time-and-expenses report, for each account. The time-and-expenses report shows revenue for all hours logged. The calculations for revenue are as follows:

 Calculated Revenue for account = Sum (Logged work on JIRA issue * price rate defined for role).

To edit price rates, open the Manage menu in the top right corner of the Accounts Navigator and select Price Tables.




Users with multiple roles

A user who is a member of multiple teams might have different roles in each team and therefore different price rates. By default, work on an issue is charged at the user's highest rate. You can set work to be charged at the user's rate for a particular team by selecting that team in the **Team** field of the issue.

Multiple Price Tables

Multiple price tables enable account managers to use different prices for different accounts. A new price table can be created by clicking on the **+New Price Table** tab. This will open a window prompting for a new name.






New Tempo Timesheets Look and Feel

With the changes to the Timesheet user interface, we wanted to create a more functional and efficient interface for our users. We removed information duplication, and reorganized the controls based on their function and scope.

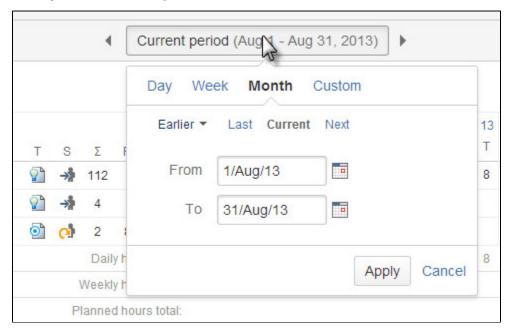
Screenshot: The new Tempo Timesheets look and feel (click to enlarge)






New Date Navigation

With this new navigation users can select the view to display in Timesheets and Reports in fixed periods, such as 7 days or 2 weeks.








Screenshot: User is selected in the Timesheet navigation and the User Picker is displayed below.



















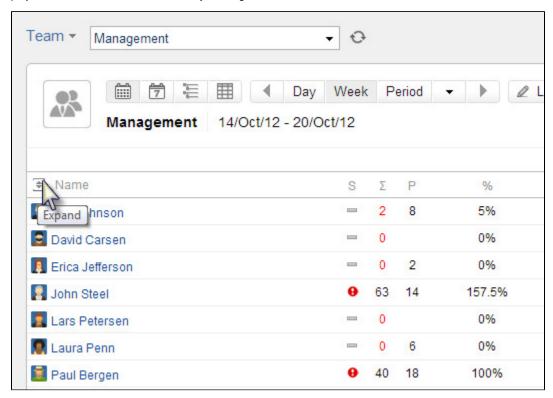















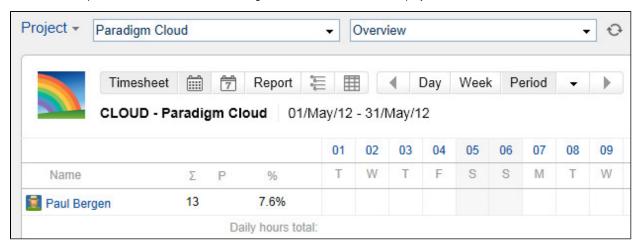



Tempo Managers will see the timesheet grouped by users while users will only see their hours. Note that the search is based on JQL and will only return issues according issue permissions.



Invalid Worklogs have been moved to the Advanced menu. As before, Invalid Worklogs show all worklogs that are invalid for some reason. 
In the new Report view, planned hours can be selected to be included in the report view, this is great when you want to review planned vs actual worked hours.





New Administration Look and Feel

We have adjusted and made some refinements to the administration panel to match the new admin changes for JIRA 4.4.



Tempo administration is displayed under Time Tracking in the JIRA Administration page.





Global Billing Keys

Billing keys can now be marked as **global**. Global billing keys are visible in all projects and the typical use case is for "non-billable" work, i.e. work that is not charged to a customer but to the organization itself.







Time Planning

User's time can be allocated to projects, versions, and components. The allocated time can then be displayed in timesheets, dashboard gadgets, and project and version pages.

The timesheet planning feature helps users and managers to get an overview of their and team's schedule and can aid in log work entry. User timesheet displays planned work for each user while team timesheet shows schedule for the entire team across multiple projects. The project timesheet gives an overview of who is planned to work on the project in a given period and is broken down to activity.

Tempo gadgets can be placed on the dashboard and on a Confluence page. They show planned versus worked time for each user. The Team Hours gadget displays planned, worked, and required hours for each team member. The People in Version gadget displays planned and worked hours for each user working on a particular version. The gadgets are great for teams and executives to track overall planned and worked time and looks great on a wallboard.



Project and version pages now also support overview of worked and planned time through the new People tabs. The People tabs display aggregation of hours for each project member broken down to activities (version and components or unscheduled).



Allocate Tempo Users to Projects, Components and Versions


Tempo admins can allocate team members to projects, components, and versions from the Plan Time dialog. Allocating a user is similar to logging work. Each allocation planned requires date or dates as well as hours per day planned and the allocation can contain an optional description. When allocating to a version or a component, a project must be selected first.






Tempo Users can Plan Their Own Time

It is useful for users to plan their own time, especially to plan non-working activities such as vacation. The recommended approach is to have a special vacation component in an internal project or a seasonal vacation version (e.g. Vacation Summer 2011) that users can plan time to using the Plan Time button.




Planning functionality is also accessible through activities in the timesheet and is simple to add by dragging the appropriate dates to pop up the Plan Time dialog for that activity. Allocations can also be edited through the inline dialog functionality in timesheets.





Planning Status Displayed in Timehseet

It is important for users to get a quick overview of their schedule and the new planning features in Tempo Timesheets aid the user by displaying activities he has been allocated to in his timesheet. The activities in User Timesheet are displayed by default if planning is enabled but can be turned off on per user. The activities show the sum of worked hours per day as well as an allocation status bar. The orange colour denotes the allocation load of the user based on his required hours for the day and the green colour displays how much he has worked relative to the allocation. Allocation can also be adjusted just like worklogs by clicking on the day cell.






Team and Project Planning Overview in Timesheet

The Team and Project timesheets have received a slight facelift to give a better overview of what users have been working on and are planned to work on. The Team Timesheet is now grouped to each user's activity, showing worked hours and the allocation status bar in each day cell. The Project Timesheet uses the same format in Project Overview but drills down to issues in Version and Component timesheets.

Managers can easily plan time in the timesheets by selecting cells in a row and the Plan Time dialog pops up with the current

context.






Worklog Date Validation

New admin function to find out why a user can't log work or edit worklogs on a specific date.

The reason why a user can or cannot add or edit a worklog depends on a combination of the following:

- Tempo period status
- Timesheet Workflow status
- Tempo Scheduler settings
- User status
- Issue Type and Issue Permission

In the new Date Validation view you get a list of all these factors and how it affects the end result.






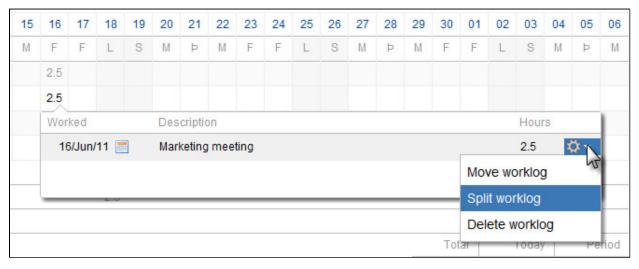
New In-line Editing Dialogs









People Pages

The planning module adds new tabs to project and version pages named "People" that displays high level information about planning.

The People tab on a project page displays people who have been planned on that project, either on project level or directly on a version or a component.



The People tab on a version page displays people who have been planned on that version as well as people who have logged work on that version. Tempo admin can allocate users directly to the version or a project by selecting the user in the user picker.



The project timesheet and GreenHopper's planning board are accessible from the Views menu.









Tempo Scheduler

The Tempo Scheduler is the first step in implementing JTMPO-26, a request to set the billing period to weekly or bi-weekly.

JIRA admins can configure the Tempo Scheduler to close, enabling logging and editing worklogs within the period. In the example below, the period starts on the first day of each month, but the executives have requested that staff complete all work logs every week. 

Period Closure and User Grace Period















Users and Groups

They also have a permission to:



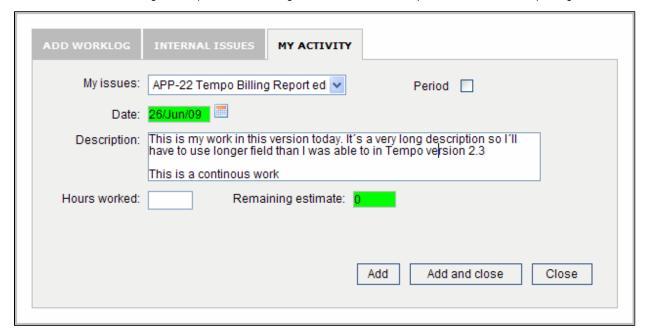




Tempo Plugin Services Access Control

JIRA administrator can select the IP addresses that are allowed to access the Tempo Plugin services.

The Tempo Plugin services are:

- · GetWorklogs: Gets all worklogs for a given period, returns data on specified format (XML, Excel or test data)
- UpdateWorklogs: Updates worklogs with external information (external ID & external hours)
- WorklogReport: Returns a worklog report as XML that can be used as input to a reporting tool
- BillingKeyList: Returns a list of available billing keys and is used when creating reports
- · HolidayList: Returns a list of registered holidays to be used when calculating required hours in an external system





New Custom Issue Type

Administrator can add a custom field of type Billing keys to be used by the Billing Key Manager.






Billing Key Manager

The Billing key manager is used to manage Billing keys of type Billing Key. The keys are created in the billing system and a UTF-8 CSV file, exported from the billing system is downloaded to the directory on the JIRA instance.

The imported file has to be generated from the billing system including the following columns:

- Billing ID
- Billing name
- Customer ID
- Customer name
- Costumer contact name
- Category ID
- Category description

The first time a file is imported, all billing keys are unassigned and can be viewed in a sorted list. They are then assigned to a Project and accessable from a dropdown list in a JIRA issue

Tempo REST API

Tempo REST API is for developers who want to integrate with Tempo add-ons. The REST API is a standard interface for interacting with the Tempo modules. Use the REST API browser built into JIRA to browse the services provided by the Tempo REST API.

Tempo servlets API

Integrating two systems is a fairly complex process; change in one system must be reflected in the other. Tempo, however, allows users to easily change worklogs, whether for something as simple as a spelling correction or the modification of a date, or for more involved tasks, such as deleting a worklog

The blog Integrating Atlassian JIRA using Tempo Plugin explains how worklogs entered in JIRA can be integrated with an external system.

The Tempo services are designed as a **Machine-to-Machine** communication and are usually not used by normal users. The services provide **ALL** worklogs regardless of permissions. The services should therefore be used with care and should only be open to a limited number of people/computers. JIRA administrators control access to the Tempo services with IP address filtering
